

# Summary Report

## Health Impact Assessment (HIA) Bills

The Health Impact Assessment (HIA) Bills dataset displays all HIA bills introduced between January 1, 2012 and December 31, 2016. This report summarizes key findings during that time period across all 50 states and the District of Columbia.

Note: this dataset only includes bills that either failed or have yet to pass. Bills that passed are captured in the HIA Laws companion dataset.


This report is divided into two primary sections:


1. General Findings – Provides a broad overview of the data shared in the maps
2. Legislative Action – Information summarized in these tables comes from coded legal data.


The Legislative Action section is further divided to show details for each state by year. This section, which is divided by state, presents details for each bill introduced, including when the bill was introduced, when an action was last taken on the bill, the current status of the bill, and the legislator(s) who first introduced the bill. Use the links below to jump within this document to view legislative action for 2012-2016. Note: we used the bill's introduction date to determine the year under which it is categorized.
